**DESIGN:** Models 9120, 9120T, 9120H, 9120F, 9120TF, 9120HF, 9123, 9123T, 9123H, 9123F, 9123TF and 9123HF single and multiple station photoelectric type, 120 VAC with non-rechargeable 9VDC battery backup, smoke detectors. Refer to listee's data sheet for additional detailed product description and operational considerations.

**RATING:**

**INSTALLATION:** In accordance with listee's printed installation instructions, applicable codes & ordinances and in a manner acceptable to the authority having jurisdiction.

**MARKING:** Listee's name, model designation, electrical rating and UL label.

**APPROVAL:** Listed as single or multiple station photoelectric smoke detectors.

Models 9123, -T, -H, -F, -TF and -HF can generate a distinctive temporal code pattern fire alarm signal (for evacuation) in accordance with NFPA 72, 2002 Edition. These units are intended for use in occupancies that require total evacuation.

Models 9120, -T, -H, -F, -TF and -HF are non-temporal and are intended for use in occupancies that do not require total evacuation but perhaps relocation or notification.

**NOTE:** The photoelectric type detectors are generally more effective at detecting slow, smoldering fires which smolder for hours before bursting into flame. Sources of these fires may include cigarettes burning in couches or bedding. The ionization type detectors are generally more effective at detecting fast, flaming fires which consume combustible materials rapidly and spread quickly. Sources of these fires may include paper burning in a waste container or a grease fire in the kitchen.
